The Ray D. Anderson CRTC is reporting that there have been 3 incidents of Prison Rape Elimination Act (PREA) investigation from January 1, 2024, through December 31, 2024.

A Summary of the 2022 audit finding shows that the Ray D. Anderson CRTC met or exceeded all 41 of the PREA standards. There were 0 standards that were found as not met.
